Mike's objective is to facilitate high quality planning and design with an emphasis on sustainable, accessible and attractive design. Mike has a demonstrated ability to coordinate and manage complex projects. At the same time, attention to detail and small-scale elements of design assure a project that functions well and is reliable over the long term.

### Institutional and Commercial

Institutional and Commercial projects rely heavily on access, transportation, parking, circulation, safety and image. Success requires that one consider the user's interaction with these elements as the organizing principals for site planning. These elements must work together to yield a setting which inspires the type of response associated with the contemplation of beauty. Not an easy thing to achieve, this result comes from an understanding of the forces that act on a site, followed by an arrangement of the elements of design so that they respond to those forces in a way that reflects both environment and program. This approach is only achieved in a situation where the client demands the highest standards, and the team is willing to both ask and answer the right questions.

- **Kimbell Art Museum Expansion and Renovation:** Assist the Owner and the Architect with site programming and landscape design for the expansion of the Kimbell Art Museum in Fort Worth, Texas. With Renzo Piano Building Workshop, Paratus Group, and Kendall Heaton and Associates for the expansion and with Harper Brawner Architects for the Renovation. The site is 10 acres with approximately half devoted to the expansion by RPBW and half to the original 1970 building and grounds by Louis Kahn ca. 1972. Sitework for the expansion includes approximately two acres of green roof (sod and trees) covering gallery space and parking, along with geothermal wells and solar access zones for thirty thousand square feet of solar panels which are mounted on structure. The renovation work involves adapting the 1970's Kahn site to changed environmental conditions which have occurred as a result of the shift from open sun to shade in many of the planted areas.
- **Woodruff Arts Center Expansion:** Assist the team of Renzo Piano Building Workshop in programming, site analysis, concept development, permitting, construction documents and construction administration for the landscape architectural portions of the expansion of the Woodruff Arts Center site in Atlanta, Georgia.
- **Georgia Institute of Technology:** Master planning and design for two edge corridors (North Avenue and 10th Street) as well as the internal corridor serving campus athletic facilities (Fowler Street). Also, sustainable re-design of the alumni / administrative parking lot.

Both the building and grounds, which cover a city block located within Newnan's historic residential district are being extensively updated to serve a new purpose while keeping this high quality resource within the historic city. ## Urban Design

Urban projects often must be carefully crafted to work within a larger context. Access, circulation, traffic and utilities are make-or-break issues for most urban projects, be they parks, parkways, campuses or large buildings. Therefore, an ability to see beyond the property boundaries to the setting, and to understand how that setting will shape the project, is critical to project success.

- **Atlanta Beltline – Sub Area 9 Plans:** Project manager, land use, urban design, transportation for approximately 3000-acre area adjacent to downtown Atlanta, along with master plan for the new Westside Reservoir Park, Atlanta's largest park. Sustainability, including a comprehensive transportation plan consisting of heavy rail, light rail, bus, bicycle and pedestrian modes along with more traditional vehicular modes are a critical aspect of this work. The project is relevant to the proposed work in that at a large scale, it is similar in size and complexity and lies within the urban context of west midtown Atlanta. At a smaller, site-oriented scale it consists of many individual projects which must accommodate large numbers of people, along with facilities for living, working and play.
